Our results support all three of our hypotheses. We find that:

- Shareholder value is positively related to business experience.
Companies with more experienced management teams have higher shareholder value.
- Shareholder value is positively related to quantitative finance.
Companies that use more quantitative finance have higher shareholder value.
- Business experience is positively related to quantitative finance.
Companies with more experienced management teams use more quantitative finance.

Our findings suggest that shareholder value, business experience, and quantitative finance are all important factors that can affect the performance of a company. Companies that have more experienced management teams and that use more quantitative finance have higher shareholder value.

Our findings have implications for companies, investors, and policymakers. Companies should invest in developing the business experience of their management teams and in using quantitative finance.
